Delivery Gift

- 1) Members shall provide an address in Malaysia to Minami for delivery of Gift. Delivery will not made to a P.O. Box address.
- 2) Delivery of any gift(s) will be sent via courier service. In the event members are not available to receive at the delivery address, members have to liaise directly with the courier services company at the specified time frame and location as stated in the "attempt card" (dropped by the courier service company) to collect the document.
